

Yakima Chernobyl Ant

Hook: TMC 2312 , sizes 10 to 6.

Thread: Tan 6/0 (140 denier).

Underbody: Tan foam extending to form a tag and head.

Body: Yellow Floss, Pearl Krystal Flash.
Rib: Brown hackle.

Legs: Medium brown rubber legs.

Back: Brown foam 2mm foam.

Wing: White or Tan Poly.

Head and collar: Red Floss .

AFFILIATION

The Fidalgo Fly Fishers have been an affiliate club member of the International Federation of Fly Fishers (IFFF) (formerly the Federation of Fly Fishers) since 1975. Our affiliate status was grandfathered two years ago when the IFFF Board of Directors changed new club's membership to Charter Clubs or 100% member clubs. (All club members must also be IFFF members.)

Why is it important that fly fishers join the IFFF? There are many reasons which are important to the fly fisher and to the sport. One important reason was emphasized in the club programs since October 2012.

Three of those programs were about fishing for sea-run cutthroat. At the beginning of each of those programs the presenter made a statement to the effect that "There are lots of sea-runs to fish for both along the salt water shore and in the rivers".

Thirty or more years ago there was a concern about the decreasing numbers of sea-runs. It was through a very concerted effort by IFFF affiliate clubs and individual IFFF members in the greater Puget Sound Region that changes were made in the fishing regulations that brought about our present cutthroat numbers. A sub-group called the Cutthroat Coalition was formed. Fidalgo members participated in fin clipping, recording fish catch, and testifying at Game Commission meetings. These efforts, along with Game Department biologist's research, brought about significant changes in the regulations. Because a sea-run does not reach egg laying maturity until they are fourteen inches long, the minimum size was increased to fourteen inches. This change would give each cutthroat a chance to go through at least one spawning cycle. Allowed catch retention was reduced to two in the rivers and streams. Maybe the regulation that created total catch and release

in the salt water made the biggest impact. The IFFF was an early proponent of Catch and Release and this idea was part of the focus during the time the Cutthroat Coalition was active.

So when you hear program presenters telling you that "There are lots of sea-runs" remember that it was members of the IFFF (both club affiliate members and individual members) that recognized the problem and brought about the changes.

Please be thinking about joining the IFFF as the club develops membership recruitment in September.

Ban on Barbed Hooks Expands on Columbia River, Tributaries May 1

OLYMPIA - Starting May 1, anglers fishing for salmon or steelhead on the Columbia River and most of its tributaries downstream from Chief Joseph Dam will be required to use barbless hooks.

The new rules extend the ban on barbed hooks another 250 miles upriver on the Columbia River and to dozens of its tributaries, including the Cowlitz, White Salmon, Klickitat, Snake, Yakima and Okanogan rivers.

Anglers fishing those waters will still be allowed to use single, double-point or treble hooks, so long as the barbs have been filed off or pinched down.

Jim Scott, assistant director of the WDFW Fish Program, said the new rule will contribute to ongoing efforts to minimize impacts

on wild stocks while maintaining opportunities for anglers to harvest abundant hatchery fish.

Fishing regulations requiring the release of wild salmon and steelhead are common in the Columbia River Basin and other Washington waters, especially in areas wild salmon and steelhead are protected by state and federal laws. In those cases, only hatchery fish marked with a clipped adipose fin and a healed scar may be retained.

The Washington Fish and Wildlife Commission, a nine-member citizen panel that sets policy for WDFW, endorsed the barbless-hook requirement as part of a broad-based policy designed to support the recovery of wild salmon and steelhead in the Columbia River Basin.

That policy, adopted in collaboration with the Oregon commission in January, also set the stage for gradually shifting non-tribal commercial gillnets to off-channel areas of the river and developing new, more selective types of commercial fishing gear.

With only a few exceptions, the rule requiring the use of barbless hooks will be in effect on rivers and streams where a Columbia River Salmon and Steelhead Endorsement is required in addition to a current fishing license.

Those waters are clearly marked in WDFW's 2013-14 Sport Fishing Rules pamphlet, now available online at <http://wdfw.wa.gov/fishing/regulations/>. The paper version of the pamphlet will be distributed to recreational license dealers around the state by early May.
